- 1) Question: Can the AIA Document A310 Bid Bond be used in lieu of the Bid Bond form in the ITB?
Answer: Yes, an AIA Document A310 Bid Bond may be used in lieu of the Bid Bond form in the ITB.
- 2) Question: What are the normal working hours and can construction occur on weekends?
Answer: Normal working hours will be from 6:30am until 5:00pm, Monday thru Friday. Work may be done on weekends, upon written approval by the College. All other work times will require written approval by the College.
- 3) Clarification to Addendum #2, Item #5: Only the cost provided by the bidder, located on page 15, section 1.8, of the bid will be required to be bonded.
- 4) Question: My surety is concerned with statement 79 on page 13. Is this just a boiler plate that you put in all of your contracts or will this contract be over after the 148 allotted days?
Answer: This is boiler plate language which is included in all of the College's bids. The date for Final Completion date of the bid is Thursday August 25, 2011. Any attempt to extend the bid by the contractor will require written permission by the College.
