

## Dual Enrollment Registration Deadline for Home School Students

Students who wish to dual enrollment at CFCC must have an application, an Intent to Establish a Florida Home Education Program form (Marion County) or documentation from the Citrus or Levy County School Board Office, and eligible (passing all sections) copies of original test scores to Katie Stephenson, the Dual Enrollment Coordinator, by one of our two application deadlines. General Marion County Information: Returning students will register on priority registration day. Returning students will be registered by our advisors on a first come, first served basis from 9am to 12pm and new applicants will be registered from 2pm to 4pm. Students will be allowed to sign in starting at 7:30am and they must be present to sign in and have the proper paperwork with them. Students must have their permission letters with them when signing in. Students also need to select the section number for the desired classes and an alternate in case the course is full. A parent or guardian may accompany their student on registration day, but their presence is not required for students to enroll.

General Citrus and Levy Information: Home school students in Citrus and Levy County can fax at 352-873-5821 or scan and email their class requests to Katie Stephenson, DE Coordinator. Class requests can also be mailed. Class requests must come from the student's parent or guardian and must be signed. Registration will be done on the priority registration day.
