

## Dual Enrollment Registration Deadline for Home School Students

Students who wish to enter the dual enrollment at CF must have an application, an Intent to Establish a Florida Home Education Program form (Marion County) or documentation from the Citrus or Levy County School Board Office (letter on letterhead from home school office), and eligible (passing all sections) copies of original test scores to Katie Stephenson, the Dual Enrollment Coordinator, by one of our two application deadlines as seen below. General Marion County Information: Returning students will register on priority registration day. Returning students will be registered by our advisors on a first come, first served basis from 9am to 12pm. Students will be allowed to sign in starting at 7:30am and they must be present to sign in and have the proper paperwork with them. New applicants who qualify by the priority deadline will be registered from 2pm to 4pm. All students also need to select the section number for the desired classes and an alternate in case the course is full. A parent or guardian may accompany their student on registration day, but their presence is not required for students to enroll.

If a student qualifies and turns in an application after the priority date, but before the final registration deadline, they will register on the final registration day at 9am. If a student is retesting in one area and qualifies sometime between the priority deadline and the final deadline, they will still register on the final registration day. If a student qualifies for the priority application deadline but the student or parent is unable to attend registration day, they must register on the make up/final registration day or call for an appointment after the final/make up registration day.

General Citrus and Levy Information: Home school students in Citrus and Levy County can fax at 352-873-5821 or scan and email their class requests to Katie Stephenson, DE Coordinator. Class requests can also be mailed to College of Central Florida Attn: Katie Stephenson/DE 3001 SW College Road Ocala, FL 34474. Class requests must come from the student's parent or guardian and must be signed. Registration will be done on the priority registration day.
